NATURE OF PROCEEDINGS: Ruling on Submitted Matter Re: Account - Trust (Subsequent) filed on May 6, 2021 by Jeffrey Siegel.

The following parties are present for the aforementioned proceeding:

Out of the presence of the court reporter, the Court makes the following findings and orders:

The court having taken the Third Account Current of Temporary Successor Trustee (filing date 5/6/21) under submission and having re-reviewed the accounting, the objections filed by Ernest Moore on 9/9/21 and 9/28/21 and the response filed by the Temporary Successor Trustee on 9/23/21 makes the following orders:

- 1) The Third Account Current filed on 5/6/21 is approved, ratified and allowed as filed and supplemented.
- 2) Trustee Fees in the amount of \$48,678.00 are approved and ordered paid by the trust.
- 3) Attorney Fees of \$90,735.00 are approved and ordered paid by the trust.
- 4) The Objections filed by Ernest Moore are overruled in their entirety. The Third Account Current picks up exactly where the approved Second Account Current left off. The objections concerning the Moore Family Trust have no bearing on the Third Account Current in this trust proceeding. The accounting balances as required because the charges and credits equal each other. The proceeds from the sale of the Holmes Avenue property are properly reflected and accounted for (in terms of probate accounting) in the Third Account Current. The accounting also correctly accounts for disbursements made on the Corbett Street property for the period of time that this property was a trust asset prior to the court ordered transfer to Jean Robinson.
- 5) The Objections of Jean Robinson are moot since the same were withdrawn on the record this date.

The Court orders the Clerk to give notice.
