To: Supervising Judge Brenda J. Penny,

This is my second written complaint about a judicial officer in your Probate Department 11. The first complaint was filed with the former supervising probate judge against *Judge Barbara Johnson*. The pattern of misconduct and disregard for any laws as well as prejudice by the current judge on my probate case now by *Ana Maria Luna*, is similar to that of Judge Barbara Johnson!

I have documented a few of the violations by judge Ana Maria Luna in my declaration that was filed in the *Britney Jean Spears case* "*DECLARATION OF ERNEST MOORE AS INTERESTED PARTY & ADVOCATE SEEKING PROBATE COURT REFORMS*" on October 22, 2021, as well as other multiple egregious violations in past years of the probate & conservatorship cases that I am a party to. As far as I know, I have not seen any response from you or any of the lawyers in the Britney Jean Spears case to date. I have attached my declaration to this letter.

I am demanding that you disqualify and remove judge Ana Maria Luna from my probate case immediately and replace her with an ethical, fair, and competent judge that can follow all laws pertaining to the probate litigation in my case.

Judge Ana Maria Luna has caused irreparable harm to the trusts in my probate case. In my case, Judge Ana Maria Luna has made false and misleading statements pertaining to probate laws and court procedures that she has presided over! She continues to ignore the law or is totally ignorant of the California probate trust litigation laws and is only acting to cover up the crimes of the other parties in my case.

During the time that Judge Luna has presided over my case, she has committed but not limited to the following violations as a judicial officer that I consider to be criminal misconduct:

1.) Judge Luna has granted sanctions against me from a motion filed by the attorney for my sister Daniel Herbert based on false and misleading statements *(stupid lies)* about the law and circumstances around a mandatory settlement conference. Judge Luna granted his sanctions against me but did not grant any sanctions against him for his professional misconduct and CA BAR violations!

2.) Before the March 24, 2021 trial to remove the court-appointed temporary trustee Jeffery Siegel and order for sanctions against him and the former co-trustee Jean Robinson, she denied my Ex parte to continue the trial based upon several issues, including that this corrupt trustee is behind on the accountings for the Myrtle Moore

Living Trust for about three years! Another major issue was a foreclosure on the apartment building that I had inherited from my mother's trust going on at the same

time. <u>See Minute Order for the March 24, 2021 trial with prejudice void orders</u> <u>attached</u>

3.) Judge Luna denied my ex parte to stay the foreclosure based on her only false justification that I have <u>no standing in this probate case!</u> I filed a petition for writ of supersedeas with the 2nd Appellate District court, and it was also denied! <u>See Minute</u> <u>Order for the prejudiced July 6, 2021 void denial of ex parte</u> & See 7/16/2021 ORDER from Appellate court.

4.) Judge Luna then proceeded to force me into a trial without all the evidence I needed. She also refused to accept judicial notice that the former co-trustee Jean Robinson had been removed as co-trustee due to her fraudulent accountings and has not disclosed what she has done with millions of dollars from the Moore Family Trust and the Myrtle Moore Living Trust! <u>See July 21, 2015 Order suspending co-trustees</u> <u>and appointing temporary trustee</u>.

5.) Judge Luna then proceeded to deny all of my requests from petitions that I filed *with prejudice*. See attached minute orders.

6.) At the hearings for the accounting from the temporary court-appointed trustee Jeffery Siegel, judge Luna disclosed that she was going to approve the fraudulent accountings for false justifications again before the first hearing, but the lawyer for my sister Jean Robinson requested to continue the hearings so he could obtain the financial documents that I requested in my objections to all of the accountings in the Moore Family Trust & the Myrtle Moore Living Trust.

Daniel Herbert never produced these documents that would have proven that he lied about transferring all of the assets from the Moore Family Trust to the Myrtle Moore

The current court-appointed trustee *Jeffery Siegel* did nothing to prove that he was lying or to recover any of the lost assets! In his responses to my objections, Daniel Herbert gave *"dog whistles"* to judge Luna to mess me up with sanctions for filing objections to their fraudulent accountings to violate my rights further!!! <u>See Jean</u> *Robinson's response to 3rd account attached*

7.) Judge Luna approved the fraudulent accountings by Jeffery Siegel on 12/8/2021, stating that the Moore Family Trust has nothing to do with the Myrtle Moore Living Trust, which is a **bold face fucking lie!** <u>See December 7, 2021 void Order</u> <u>Approving 3rd Account Current</u>

8.) Judge Ana Maria Luna has a long string of victims from every court that she has presided over! She is not mentally or morally fit and has significant demenished intelligence that would preclude her from serving as a judicial officer in our judicial system or practicing law in the legal profession in any capacity! See the ratings for judge Ana Maria Luna in my declaration supporting relief for probate court victims in the Britney Spears case.

Conclusion

I respectfully request that: You better put your foot so far up this Bitches Ass that she can smell your feet every time she opens her mouth to say another set of lies!!! You better get this **"Bench Bitch"** off my case and put her in jail by next week! This <u>type of</u> <u>corruption and violations of my rights will not be tolerated!!</u>
